#### **Questions about the Trial**

- What is the purpose of the trial?
- Why do researchers believe the trial treatment may be better than current treatments?
- Is there a reason the trial treatment might not be better?
- How long will I be in the trial?
- What kinds of tests and treatments does the trial use?
- How will the doctor know if the treatment is working?
- How will I learn about the trial's results?
- When do I have to make up my mind about this trial?
- Who can answer questions I have during and after the trial?
- Who will be in charge of my care?
- Can I talk to someone who has been in the trial?
